#### 2002 GRANT RESEARCH PROJECT

Jay Abercrombie, Biologist, has approved this report. A final payment of \$206.27 is outstanding.

## RESEARCH GRANT—2003 SMALL GRANT RESEARCH PROJECT

This project would conduct research on Silver Creek using a monitoring data device called a data logger. The cost for this grant research project is Two Thousand Dollars (\$2,000.00).

#### BASS LAKE PRESERVE FISH STUDY

Keith McClintock informed the Board that he received a request from Rob Sylak of Chagrin Watershed Institute requesting a permit to conduct a minimally intrusive fish study on Bass Lake. This study would gather baseline data information on the fish populations for future tracking of fish and would run for three years. All data will be reported to Geauga Park District on an annual basis. Geauga Park District would not incur any expenses with this three-year fish study. Mr. Sylak will be enlisting the aid of students from Chardon High School and Shaker High School. Through this study the students would learn limnology and lake ecology while gathering the data. We have granted Mr. Sylak a special use permit.

#### **COMPENSATION SYSTEM**

At the June 10, 2003, Board meeting, Chris Belz from Belz and Associates, Inc. presented to the Board a proposed compensation system for Geauga Park District employees.

#### **BEST PRESEVE DAM REPAIR CONTRACT AWARD**

## **EPD CONSULTANTS INC. - CHANGE ORDER NO. 1**

#### **PARK UPDATES**

Mr. McClintock shared the following updates with the Board:

#### **Bass Lake Preserve**

Jim Ziemnik, Landscape Architect, met the Ohio Environmental Protection Agency (OEPA) concerning the Bass Lake System. OEPA indicated that Geauga Park District could make improvements to the present system. The system needs a lift station and sand filter. Tim Kallay, Contract and Planning Director, will review the structure roof system on July 10<sup>th</sup> by cutting additional holes in the ceiling to see if the recommended reinforcement steps were implemented in the mid-1990s.

#### **Big Creek Addition and Ranger Garage**

Work continues with the interior trades on the Big Creek expansion project. The substantial completion date is August 1, 2003, with a final completion date of August 29, 2003.

#### **Ellerin Property**

The demolition work on the property has been completed. The Land Stewards have seeded and mulched the property.

## **The Maple Highlands Trail-Central**

Plans and specifications are under review at the Columbus office of the Ohio Department of Transportation (ODOT). The office of Environmental Services will be meeting with Geauga Park District staff for a walk of the project site to review the wetlands and the possible project impacts.

#### The Maple Highlands Trail-North

Repairs to the asphalt did not address concerns for subsurface rutting that occurred during the replacement of the pavement. It also does not address concerns for fine cracking in the surface. Geauga Park District is not satisfied with their suggestions. Tim Kallay would like to have the asphalt broken up, using the asphalt as a base, and then repaving.

The gas line reimbursement has been refused. We have requested ODOT to send us a copy of the federal law that applies to this situation. To date, we have not received the applicable federal law.

#### The Maple Highlands Trail—Parking Area

Plans for the parking area for The Maple Highlands Trail were submitted to ODOT in April. We received ODOT's comments to these plans. Richland Engineering Inc. is making the necessary changes. These plans will then be resubmitted to ODOT. Tim Kallay anticipates construction to commence at the end of August or September. It is a three-week project.

#### **The West Woods Nature Center**

Raytec Systems has been asked to give a quote for an intercom system, a hook-up for the nature store for a credit card reader, as well as ceiling speakers at The West Woods Nature Center. The HVAC warranty has not been received. We are continuing to monitor the temperature of the well

field to see if we need to add the glycol. We are checking with Tony Paskevich's office to go ahead and install the ice guard that was to be on the roof. Jim Ziemnik is prioritizing the work that needs to be done at the Affelder house.

#### Middlefield Right-of-Way

The Middlefield Village engineer will be at the Village council meeting on Thursday, July 10, 2003, to go over plans. Once brush hogging is complete, the bridge will probably be the first thing done. Final improvement plans were submitted to Tom Sterlekar, Park Technician, yesterday. Crew will be able to park at the Ronyak Warehouse and walk back approximately ¾ of a mile.

#### Dark Sky Walk

lan Cooper from the Chagrin Valley Society will be conducting a search for a good location for the donated telescope on July 25<sup>th</sup> and has extended an invitation to the Park board members.

#### **Land Appropriations**

July 14<sup>th</sup> will mark the end of the 28-day response period to our appropriations actions regarding the railroad right-of-way. To date, we have not received any responses.

#### The Trust for Public Land

Mr. McClintock informed the Board that if they have not yet received an invitation, they would be receiving an invitation to an event celebrating the conservation of Bass Lake hosted by The Trust for Public Land along with Jerry and Kathy Petersen and Steve and Lorri Petersen. This event will take place on Sunday, July 20, 2003, from 1:00 p.m. to 4:00 p.m.

#### **Pending Litigation**

We are currently undergoing a state audit. David Ondrey, legal counsel, received a request from the state audit as to the pending litigation for Geauga Park District. We have received a copy of David Ondrey's letter as to our liabilities. Mr. Ondrey informed the state audit that our range of loss would be less than \$10,000.00.

#### **Tim Smith Pond**

Mr. Smith had sent a letter to Geauga Park District stating that he was having problems with silt and debris in his pond that he felt was a result of the work the Park was doing on The Maple Highlands Trail. Mr. McClintock reported to the Board that we received a letter from the Ohio Environmental Protection Agency (EPA) with reference to this situation. The Ohio EPA stated that the Park District was in compliance with the permit for The Maple Highlands Trail.

## <u>Silver Creek Stream Restoration Project - Notice of Public Hearing</u>

Mr. McClintock informed the Board that the public hearing for the Silver Creek Stream Restoration Project would be held at The West Woods Nature Center on Tuesday, July 22, 2003, at 7:00 p.m. Vince Sortman, Project Manager from Biohabitats, will be presenting the project and showing slides so that the neighbors would know exactly what to expect on the floodplain.

## NAMING RIGHTS—THE WEST WOODS NATURE CENTER'S EXHIBIT HALL

Miss Cope referenced the past practice for naming procedures in the Park. The proposed name would be brought to the Board for comment, approval, and vote, if deemed appropriate. Miss Cope stated that in response to a persistent interest on the part of staff, friends of the Park, and volunteers, she and Commissioner Dr. Rzeszotarski are proposing that the Park's most recent crown jewel, namely the exciting exhibit hall in The West Woods Nature Center, be named in tribute to Commissioner Robert McCullough. Miss Cope suggested the ceremony be held over the Labor Day weekend, when, traditionally, the McCullough family gathers together or a later date in the fall if that is preferred by the McCullough's. Mr. McCullough expressed his appreciation for this consideration.

Miss Cope moved that The West Woods Nature Center's exhibit room be named in honor of Robert McCullough.
