# **HEADWATERS PARKS**

The Board was advised that the Park District received one (1) bid for the Headwaters Park Improvements project, which bid was incomplete. At the recommendation of the project architect the Park District is seeking approval from the Board to revise and re-bid the project. The revised bid would be for improvements to the shelter only. The camping improvements and construction of the double restroom would be completed by the Park District in-house construction crew. Mr. Orndorff requested that Mr. Ondrey review all bids received.

# FROHRING MEADOWS-PHASE II IMPROVEMENTS AND BUDGET AMENDMENT #2 – RESOLUTION No. 15-15

Mr. McCue made a recommendation to the Board to accept the bid and award the project to Hummel Construction for \$279,500.00 for construction of the Pavilion and Parking Lot, with non-performance of the Boardwalk and Demonstration Garden. It was also recommended that the Boardwalk and Demonstration garden be constructed by the Park District. If the non-performed items are to be constructed by the Park District an additional amount of \$20,000.00 will need to be allocated to this project by approving proposed Budget Amendment #2 – Resolution No. 15-15. Mr. Orndorff and Mr. Gertz made suggestions regarding the use of volunteers to help in the construction of the Demonstration Garden. Mr. Bellas (GPD Grounds and Facility Manager) confirmed that he has worked with Master Gardeners in the past on like projects.

Mrs. Shumway made a motion to approve Budget Amendment #2 to for supplemental appropriations to the Land Improvement Fund in the amount of \$20,000.00, Resolution #15-15.

- Recommendation of a contract award for \$279,500.00 for the Pavilion Construction and Parking Expansion as recommended by Peninsula Architects is within the \$300,000.00 budget for the project.
- A thorough reference check has been conducted by Peninsula Architects and the Park District's prior experience with Hummel Construction on the Observatory Park – Phase II Project.
- The Ohio Auditor Findings for Recovery Database yielded no results.

## **ODOT BIENNIUM FUNDING - RESOLUTION NO. 13-15**

The Board was presented with Resolution No. 13-15, which requests funds from ODOT's Park Road Improvement Fund for years 2016-2017. Mr. Oros explained that these funds are administered with assistance from the Ohio Parks and Recreation Association and can be used to cover the cost of materials and labor for road and parking lot improvements or maintenance. The amount of the fund received will be determined once the Biennium funding is approved by the State. Mrs. Shumway inquired as to where the funds would be used. Mr. McCue advised the Park District maintains a list of projects that could be funded by these monies, and the project would be chosen based on the amount of funds awarded.

Mr. Orndorff made a motion to accept Resolution No. 13-15, requesting ODOT Biennium Funding.

## VIDEO PRODUCTION SERVICES

The Board was provided with the results of the Request for Proposal (RFP) for video production services and distribution of the product. Ms. Pennell advised that due to the variance of quality and cost of the submitted proposals, she is requesting Board assistance in planning for use of the video and with the vendor selection process. Mr. Orndorff volunteered to be the Board representative for this process.

Ms. Pennell added that she has corresponded with the State Auditor and advised their interpretation was this is a service, not a product, and it is not necessary to choose the lowest bid submitted.

This item will be tabled pending further information.

#### COMMISSIONER'S TIME

Mr. Lombardy addressed the Board regarding increased cost of Microsoft Office subscriptions and changes to the way the subscriptions are purchased and managed. The Board requested that this information be submitted as an Agenda item at the April Board meeting.

Mr. Oros advised the Board that PERS contributions were not deducted for a former employee during 2014. The total amount the Park District will be responsible for correcting is \$3,741.92 (\$2,170.31 Employer Contribution, \$1,571.60 Employee Contribution). Mr. Orndorff requested the employee be notified and advised that this will be corrected.

Mrs. Shumway advised that she has researched the alleged hunting violation at Burton Wetlands by reviewing the Burton Wetlands Nature Preserve Management Plan and the Articles of Dedication – Burton Wetlands Management, citing parts that referenced the criteria and approvals needed regarding the controlling/management of animal species that have become a nuisance and that, in her opinion, Geauga Park District has adhered to the referenced plans. In addition, Mrs. Shumway advised she spoke with Tom Arbor of ODNR and that he relayed that ODNR is confident with the way Burton Wetlands is being managed.

## **OPEN TO THE PUBLIC** - below are comment summaries:

**Ed Buckles**, Troy Township, addressed the Board from the podium. Mr. Buckles requested that the minutes reflect there was a meeting held with two members of the Board of Commissioners at the Meyer Center prior to the Board Meeting that was not publicly announced and that Park District business was discussed. Mrs. Shumway advised that this was not accurate. She explained that the meeting was a retention hearing (GPD Records Retention Commission) and Mr. Gertz asked if he could sit in and listen to the meeting. The door was left open so that anyone else could also sit in and listen. Mrs. Shumway added that as a Geauga County resident Mr. Gertz had a right to attend, and that he was not allowed any input. Mr. Buckles requested the minutes reflect Mrs. Shumway's explanation.

Mr. Buckles stated that the Park District previously had an Audit Committee that looked into the Park's finance and he understands it was disbanded approximately 14 months ago. Ms. Pennell advised that the audit committee was not disbanded, but there has not been a recent meeting.

There were further discussions regarding trapping at Park District locations that were not identified or recommended for trapping by the Park District Natural Resource Management Department.

**Barbara Partington**, Munson Twp., addressed the Board from the podium. Ms. Partington welcomed Mr. Orndorff to the Park District. Ms. Partington gave an overview of the purpose of Protect Geauga Parks. There were discussions regarding permitted activities at Frohring Meadows and the impact to the property. Ms. Partington addressed the definition of recreation stating it may be misleading as it means different things to different people. In regards to Mrs. Shumway's investigation of the Burton Wetlands trapping issue, Ms. Partington stated that investigations are usually done by someone other than a

Board member (*copies of documents Mrs. Shumway referenced were supplied to Ms. Partington per Mr. Orndorff*). Ms. Partington expressed her concerns regarding the close ties that Mr. Orndorff and Ms. Shumway have to Judge Grendell and hoped that the connection can be separate and the Commissioners act as independent advocates for the Park District; Ms. Partington asked the Board to give strong thought to returning to protection, conservation and preservation.

**Thomas Foster**, Munson Twp – representing Bass Lake Club as President of the Trustees, addressed the Board from the podium. Mr. Foster stated that Bass Lake Park has always been considered a community park. The Bass Lake Club community helps look after it, and in exchange there is an agreement with the Park District to supply boat racks and other considerations. Mr. Foster stated that the current agreement with the Park District expires on April 13, 2015 and inquired if a new agreement could be reviewed and signed. Mr. Foster addressed the issue of the backstop, which obstructs the lake view and requested it be removed. Mr. Foster addressed there are no objections to the other amenities and thanked the Park District for the new boat racks. Mr. Oros stated that the Park District was waiting until the EPA requests regarding Bass Lake had been resolved, before entering into new agreement. The EPA is requesting that an additional three (3) acres be placed in an environmental covenant to replace the three (3) acres that was impacted by the addition of recreational amenities. Mr. Foster stated that he would be willing to address the EPA if it would help.

Mr. Orndorff made a motion to extend the existing Bass Lake Club Agreement for a period of 90 days from the April 13, 2015 expiration date, to allow for review of the Agreement and to address the issues raised by EPA and Mr. Foster. (90 days from April 13<sup>th</sup> is July 12, 2015)

Mr. Gertz seconded the motion and after roll-call voice vote, the motion was approved 3 – 0:

Mr. Orndorff confirmed with Mr. Foster that the only change that Bass Lake Club is requesting is the removal of the backstop. Mr. Orndorff supplied Mr. Ondrey with a copy of the Agreement for review.

**<u>Kathleen Webb</u>**, Munson Twp.-Bass Lake neighborhood, addressed the Board from the podium. Ms. Webb thanked Mr. Foster, but requested the Board consider removing not only the backstop but removing or relocating the soccer backstop which also obstructs the lake view. Ms. Webb suggested removal of the sand volleyball court that geese are using as a litter box – then children are playing in it. Ms. Webb stated she was told by someone else in the community that the outside light may be attracting groups of young people who participate in drinking alcohol which is not safe with a lake nearby.

**Marcia Rubin**, Bainbridge Twp., addressed the Board from the podium. Ms. Rubin advised she drove over 40 minutes to get to the meeting and requested the Board consider having some of the meetings at The West Woods as she felt it was a more central location. Ms. Rubin expressed her concern that the Board meeting minutes are not made public until they are approved, and the fact that items are already voted on and approved. Mr. Ondrey, Park District legal, counsel advised that this is typical practice of every political subdivision that he is aware of – that the minutes of the last meeting are approved at the next meeting, and this is not an unusual practice. Ms. Rubin stated that 3:30 p.m. is an unreasonable time for Board meetings, eliminating individuals with jobs from attending and giving input. In regards to the survey, Ms. Rubin stated that out-of-county individuals/non-tax payers should not have input on

regarding what goes on in Geauga Park District. Mr. McCue advised that analysis of the survey will separate in-county from out-of-county responders. Ms. Rubin is concerned about the balance of the Board and the leverage Judge Grendell has due his relationship with two of the three Board members.

**Frank Jacobson**, South Russell Twp., addressed the Board from the podium. Mr. Jacobson stated he agreed with Ms. Rubin's comments. He asked if he heard correctly that \$99,000.00 was being spent on a playground, and asked who would take children all the way out to Headwaters to play on a turtle.

**John Augustine**, Parkman Twp., addressed the Board from the podium. Mr. Augustine welcomed Mr. Orndorff to the Board. Mr. Augustine provided information to the Board which he requested be entered into the minutes (see "Exhibit B"). Mr. Augustine initiated discussions regarding trapping at Burton Wetlands, i.e. ODNR's failure to ask why trapping was necessary there; he inquired why trapping was necessary at The Rookery and stated he would be looking into the agreement with the prior owners of Pinebrook regarding trapping, and access to the property.

**Joy Keco**, Ohio Horsemen's Council, addressed the Board from the podium. Ms. Keco inquired as to the cost of the turtle (Headwaters Park playground), and was informed the turtle was a component of the playground. The entire playground will cost \$99,750.

Phil Gingrich, Middlefield, addressed the Board from the podium. Mr. Gingrich advised that he retired from Geauga Park District about twelve (12) years ago and he is responsible for writing up almost all of the Management Plans. He believes the Management Plan Mrs. Shumway recited from was misinterpreted. There were discussions regarding types of animals that were trapped, locations where trapping was permitted and who performed the trapping during Mr. Gingrich's tenure at Geauga Park District. Mr. Gingrich stated that the point he was trying to make was that the trapping had to be necessary (for nuisance animals only) and other alternatives were explored before trapping took place. He added that staff and the Army Corp. of Engineers were involved in the decision making regarding the necessity of trapping. He further stated that muskrat and beaver can be destructive, but sometimes the damage can be controlled with creative structures, eliminating the need to trap, as beaver are a very important part of the eco-system. Mr. Gingrich stated that trapping should only be done if you absolutely have to, and there has to be proof that there is structural damage to infrastructure or the ecosystem, and he is opposed to trapping at Burton Wetlands. He added that he is the individual who did the research on deer management which resulted in structures being set up many of the Parks to determine if there was a deer browse problem. There were discussions on access (public and for hunters/trappers) to Burton Wetlands due to its designation as a Preserve, with Mr. Oros stating issuing a permit for Burton Wetlands was an oversight, and that the trapper did not utilize it. Mr. Oros added that trapping and hunting is a method for controlling populations, and that many of the county residents enjoy trapping and hunting. Mr. Gingrich advised the Board that in the late 90's a Director was fired for deer hunting in Burton Wetlands. He stated he felt that there must be more studies to determine that hunting and trapping is necessary in the Parks, adding that he visits all the Parks and he has not seen the necessity at Burton Wetlands. Mr. Gingrich stated he felt since his name has been brought up in two Board meetings in a row, he needed to set the record straight, and he felt that there is a lot more thought that needs to go into the process.

**Joe Sweet,** Munson Twp. (Bass Lake Resident), addressed the Board from the podium. Mr. Sweet stated that his and other families love the recreational additions at Bass Lake. He added that he appreciated all the passion in the room and the work the Board is doing.

**Stan Piekos,** Newbury Twp., addressed the Board from the podium. Mr. Piekos inquired as to why Sap's Arisin' in only being held for two weekends this year, and why with the emphasis on recreation there was only one Naturalist led cross-country skiing program (intro to cross-country skiing) was held this year. Ms. Pennell advised the decision was made to reduce the number of days for Sap's Arisin', but more activities were added including the return of horse-drawn wagons, and that she would research and advise Mr. Piekos regarding the lack of cross-country skiing programs. Mr. Piekos inquired how many additional private agreements there are with the private groups, preserves and the Park District. Mr. Oros advised that the Park District was doing a review of the Park District agreements in place. To save paper, Mr. Piekos suggested that the Park District have a supply of Agendas available for meeting attendees if they want one, instead of placing the on all the available chairs.

## **EXECUTIVE SESSION**

Mr. Orndorff made a motion to enter Executive Session to discuss legal issues, personnel and land acquisition.

Mr. Gertz seconded the motion and after roll-call voice vote, the motion was approved 3 – 0:

It's not offest that an interim director "palls one over" on the Geauga Park Board but me-might well wonder if John Oros has dene just that. The Natural Resources Management (NRM) department provided the Park district with recommendations last fall on Park areas and species that they would recommend for trapping during the following trapping season. Trapping is sometime recommended if no other feasible management is possible. NRM listed six parks and two species, to be included in the parks trapping lottery for this season. These six parks are Oukton Preserve (muskrat), Hyde-Kaplan Preserve (benver), Bass Lake Preserve (benver), Bearlown Lakes Reservation (muskrat), Fröhring Meadows (muskrat), and Orchard Hills Park (muskrat). The only other park identified as having musance animals was The Rookery whose raccoon problem was being taken care of by the Ohio Dept. of Agriculture in an effort to boliser the population of a state threatened turtle. It would be logical to assume these areas would be the only park areas trapping would be permitted.

How then, obviously unbeknownst to the park board did 5, you read right, F-I-V-E additional park areas get added to the lottery and assigned to trappers? These parks which had absolutely no nuisance animals identified on them included Beover Creek Preserve, Walter C. Best Preserve, The West Woods, Big Creek Park, and Burton Wetlands. Furthermore, none of the permits issaed to trappers, save one, had any animal species identified for trapping presumably giving the trappers free roin to trap whatever their heard's desire including River Otters. The only permit that identified a species was Big creek Park and the species was racoon. Humannumm . Racoons? . Did not John Orus assure the Park Board, asdience and questioning citizens at two commissioners meetings that nothing hut Coalbear traps (Instant kill traps) were being used in this lottery? I doobt there are many, if any, instances of racecons being trapped beneath the surface of the water in Coalbear traps. Foothold or leghold traps would be the most likely form of traps used for the species. It's not uncurrent on the leghold traps would be the most likely form of traps used for the species.

So now we move on to the Burton Wetlands Preserve. This is not a typical Geauga Park but one that in 1999 was dedicated as a State Nature Preserve by the Ohio Division of Natural Resources. State Nature Preserves come with their own set of rules and regulations, and despite the fact that the GPD is the actual owner of the property, that does not mean the park district can neglect to follow the rules in the Articles of Dedication that was signed by the Geauga Park District and the Ohio Department of Natural Resources. Per information I've received from the State, the deed states that any hunting or trapping for species management is allowed only after consultation with the Ghio Natural Areas council. My understanding is that the criteria for determining the nuisance status of a given game species, as well as the management of controlled or public hunts(Including trapping) shall be determined by the Park District with the advice of the Division of Natural Areas and Preserves, and subject to all applicable laws and regulation of the Division of Wildlife. This was obviously not done us no musance species were identified in Burton Wetlands Preserve.

One may well ask : "What gives?" Why the sloppy permitting(ranger department?) and serious lack of documentation of what has been going on regarding trapping? Why the apparent violation of rules and not following Natural Resources Management recommendations? The Park Commissioners are currently evaluating applicants for executive director and will be conducting interviews this month. I would urge them to consider the importance of hiring a director with a clear understanding of why Park Districts were started, a person who values protecting fast disappearing natural areas and a person who does NOT look on parks as places ideal for conducting personal hunting/trapping operations. Hopefully we'll have a director who understands that trapping should be a last resort tool to preserve biodiversity and NOT a favor to be doled out to one's trapping buddies. One would hope for a director who does NOT look on park land primarily as "Vacant Land" on which to put sports and other recreation facilities or talks mainly about how many thousands of people he or she can attract to the next park activity or cram into a park in a given season. Park areas ARE for people but in this relatively small percent of the county that is Geauga Parks(3.5%) PRESERVE, CONSERVE, PROTECT, should come first. Let that be a deep seated philosophy of our new park director
