# GEAUGA PARK DISTRICT BOARD OF PARK COMMISSIONERS BOARD MEETING MINUTES October 13, 2015

The regular meeting of the Geauga Park District Board was held October 13, 2015 at The Meyer Center, Chardon Twp., Ohio. The meeting was called to order at 3:30 p.m. Commissioners Mary Ruth Shumway and Bill Gertz were present.

Mary Ruth Shumway called the meeting to order. The Pledge of Allegiance was recited.

### **ADOPTION OF THE MINUTES**

The Board was presented with minutes from the September 8, 2015 Regular Board meeting.

Mr. Gertz made a motion to approve the September 8, 2015 Regular Board Meeting minutes, as presented. Mrs. Shumway seconded the motion and after roll-call voice vote, the motion was approved 2-0.

**<u>OPEN TO THE PUBLIC</u>** – below are comment summaries:

- <u>Ed Buckles</u>, Troy Twp., expressed concern over use of firearms at Chickagami Park, and that the survey results have not been published, complimented the Park District on the Interurban Railroad kiosk at The Rookery and the signage at The West Woods outlining the history of Silver Creek.
- <u>Shelley Chernin</u>, Russell Twp., stated her position on the lack of Board responsiveness to her inquiry regarding the discharge of firearms at Liberty Camp. Ms. Chernin reported that Protect Geauga Parks contacted local legislature in June in opposition of House Bill 8, and that they will receive notification of any future hearings.
- <u>Dave Partington</u>, Munson Twp., thanked John Augustine for his assistance in videotaping the Park Board meetings for others to view, and invited all to attend Protect Geauga Parks' October 24, 2015 program at Kent State Burton titled "Back to the Wild".
- <u>Mr. Gertz</u> stated, for the record, that he agreed with Mr. Augustine's article regarding Parkman Twp. and asked Mr. Oros to respond to comments relating to Liberty Camp. Mr. Oros stated the Park District issued a Special Use Permit to the Tea Party to hold a 5-day Liberty Camp. He stated the American Legion did a 21 gun salute at the Park District's flag pole dedication ceremonies and he saw no harm in permitting Liberty Camp to discharge flintlock firearms that utilized black powder and no projectiles.

- John Augustine, Parkman Twp. stated that Ranger Sloan would not provide him information on whether the discharge of firearms at Liberty Camp was being investigated, commented on the cost of the new Headwaters shelter and that the Park District is no longer using recycled paper for its newsletters.
- <u>Kathy Hanratty</u>, Chardon Twp., stated that in 2014 the duties and authorities of the Executive Director were truncated per the Bylaws and inquired if the Bylaws had been changed back to allow more authority to the Executive Director.
- <u>Linda O'Brien</u>, Russell Twp., stated she is responsible for Liberty Camp, thanked Geauga Park District for use of its park and added she and her family enjoy the Park District in many ways.
- <u>Kathleen Webb</u>, Munson Twp., asked since the Survey indicated the people want more park land, when the Board would start looking at property to purchase.
- <u>Skip Claypool</u>, Geauga County citizen, commended the Park Board on the job they are doing, and that he and many other residents feel Park property should be used in a balanced way.
- <u>Joy Keco</u>, Bainbridge Twp., said all she has heard today is that Protect Geauga Parks is against having children in the Parks which is not true they want children to be in the Parks enjoying and learning about nature.
- <u>Garrett Meyer</u>, Auburn Twp., commented on editorials that suggested playgrounds are not needed in the Park District adding he felt that a playground in the Park District is a great way to get children out in natural areas and that partisan policies should not stand in the way of making our parks better.

# JUDGE TIMOTHY GRENDELL

Judge Grendell introduced himself and spoke on the following:

# House Bill 8:

Judge Grendell brought House Bill 8 to the Board's attention, referencing his letter of May 8<sup>th</sup> to them (copy provided to all in attendance at meeting) and the potential environmental impact that the passage of this Bill would have to Park District property. Judge Grendell stated that this Bill passed the Ohio House 98-0 and should it pass in the Ohio Senate, it would allow horizontal drilling on Park Property if park neighbors obtain the approval from the ODNR Division Chief to include neighboring Park District property in their drilling unit. He added that currently the only public properties exempted from this Bill are State Parks and that Senator Eklund is introducing an amendment to the Bill that would include County Parks as exempt. Judge Grendell urged all to contact State legislature to support Senator Eklund's amendment prohibiting drilling in County Parks and other public properties.

# Liberty Camp:

Judge Grendell stated that Liberty Camp is a nationally recognized program that educates children about our founding principles, our founding fathers and the liberties and freedoms on which this country is based (Liberty Camp video shown). Judge Grendell stated that Liberty Camp is an example of what volunteerism in this county can do to help educate and prepare children for the future. Judge Grendell, on behalf of Geauga County Probate and Juvenile Court, presented Certificates of Commendation to Geauga Park District, John Oros, Linda O'Brien, and Skip Claypool for their contribution and execution of the Liberty Camp Geauga in educating the youth of the county in the history of our country. Ms. O'Brien and Mr. Claypool expressed their appreciation to all the volunteers that contributed to Liberty Camp.

#### **RANGER CANINE UNIT UPDATE**

Lt. Sloan reported that the Union would have no issues with a Park District Canine Unit and that a contractual agreement between the canine handlers and Park District is being prepared for legal review.

#### PARK DEVELOPMENT PROJECT UPDATES

Frohring Meadows shelter is complete and Headwaters is on schedule for completion this year.

#### **CASH TRANSFER, RESOLUTION #37-15**

The Board was presented with a request to transfer \$25,000.00 from the Retirement Reserve Fund to the General Fund, which amount represents retirement severances in excess of budgeted estimates.

#### COMMISSIONERS' TIME

The following items were brought forward during Commissioners' Time: John Oros:

- Tami Gingrich located an "American Snoutnose Butterfly" in Geauga County a specie that is not native to the area.
- The Tree Tops Nature Store will feature 5 new children's books by local author Mia Colten that reflect the seasons and nature.
- The Observatory Park "Super Moon" program had over 800 in attendance.
- The Fall Fest at Swine Creek had 1,250 (conservative number) in attendance celebrated Fall and the grand opening of Maple Highlands Trail South
- Park District video spots highlighting Observatory Park and a Family spending time in our parks were previewed.

Mr. Gertz: Fall Festival was well attended and volunteers are the heart of the Park District Mrs. Shumway:

- Stated that John Oros will have all GPD trails reviewed for proper usage.
- Bridges at Beartown now have a sand-type paint on them to help eliminate slipping.
- The Park District is responding to the public survey by providing events such as Fall and Frozen Fest.
- In review of a 2012 video tape made at a Township Meeting Tom Curtin attended she stated Mr. Curtin made the following comments:
  - Paving of MHT South would not occur due to budget restrictions. *Mrs. Shumway stated the Park District is now reviewing to determine if paving of MHT South could be accomplished.*
  - The house at Burton Wetlands should not come down due to the Oak Trees. *Mrs. Shumway stated that the Park District will be conscious of the Oaks surrounding the building.*
  - Geauga Park District would not be purchasing any additional property in the future and would concentrate on improving the infrastructure within the Parks. *Mrs. Shumway stated this is what the Board has been attempting to do within the last year.*
- Liberty Camp: In reviewing the camp Mrs. Shumway determined that they did not shoot guns with projectiles they did the same that was done by the color guard at the Park's flag raising ceremonies and concluded from her investigation that there was no problem with their activities.
